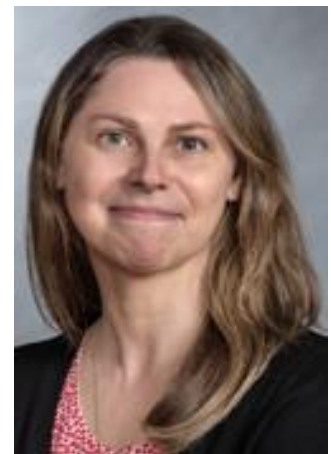

ACCUO AGM June 17, 2020

One of the highlights of our AGM was an ACCUO Statement of Solidarity with Black Lives Matter. “ACCUO stands in solidarity with the black community and condemns anti-black racism...” The full statement can be found on accuo.ca. ACCUO has created an EDI (equity, diversity, inclusion) committee to provide educational forums for members to address systemic racism. Details of EDI’s summer activities are highlighted in the following reports.

EDI Ad Hoc Committee Update – submissions of Laura Reid and Julie Boncompain

The EDI Committee has been busy over the last few months. After ACCUO released the statement of solidarity in support of Black Lives Matter, the group met to develop a mission statement and mandate. A smaller working group also met to draft a survey for ACCUO members. All of these components are in the process of being finalized and we are looking forward to sharing the results with ACCUO membership shortly. The group hopes to support and educate ACCUO members, both by sharing information about EDI initiatives happening at our institutions, and by looking inward at the ACCUO and our own policies, practices and operations to promote equity, diversity and inclusion.

During the summer, the members of the Equity and Diversity(EDI) ad hoc Committee met twice, to review the statement of solidarity, propose a mission statement and action plan for 2020-2021 to the ACCUO Executive. Following the Executive meeting of September 9, 2020, the EDI ad hoc committee will meet to consolidate the suggestions received and move forward with our action plan. We will keep you informed.

International Relations Committee (IRC) – submitted by Julie Boncompain

Over the summer, the IRC communicated to ACCUO’s members articles that were published from the international community (see accuo.ca) and informed members of upcoming webinars from European Network of Ombuds in Higher Education (ENOHE) and the African Ombudsman Research Center (AORC) that were held this summer. In the Fall, the IRC intends to review its plan of action considering the impact of the pandemic on its activities, i.e. joint partnership with ENOHE that was to take place in Greece will be postponed to 2022.

Communications Team

This team was quiet over the summer but will be meeting later this fall to continue their outreach work with postsecondary institutions across Canada. They have an extensive document showing all the institutions they have been contacting. We plan to have an update in our November bulletin.

ACCUO Western Regional Meeting August 2020

Tanny Marks, Arbiter of Student Issues, Vancouver Community College, hosted this virtual event. Topics included: Using Distance Servicing Beyond COVID; Incorporating the Black Lives Moment into the Office: Our response, as action as Ombuds-VCC; Decolonizing our Practice: Concrete Measures Taken and To Take - VCC; How to support the Ombuds/College/University Indigenization Process - VCC; the SFU environmental scan into Ombuds programming and supports, with a special emphasis on serving Indigenous Student with special guest: Chantelle Spicer, Research Assistant at SFU; Ombuds Office Reviews and Quality Assurance – VCC; Specialized Report on Graduate Students and Fairness – SFU, UVic; and Academic Integrity Amidst Covid and University responses; Exploring Possible HE Ombuds Responses on Mandatory Minimum Sanctions (for Cheating Cases) – UAlberta. On September 15, 2020, the Board of Directors appointed **Me Julie Boncompain** as the Ombudsperson of Polytechnique, Montreal, following Mr. Michel Villard's tenure in the position with rigor and integrity since 2014. Holder of a bachelor's degree in political science (Management / Administration - 1996) from Concordia University and a bachelor's degree in law from the University of Montreal (LL.B. - 1999), Julie was admitted to the Quebec Bar in 2003 and obtained the title of accredited mediator in 2009 and arbitrator in 2016. A lawyer with seventeen years of practice and having particular expertise in alternative, dispute resolution (ADR) in areas related to education, labor and business law.
